Board of Director's Meeting October 5, 2017 Visa Building, 12301 Research Blvd., Building 3 Austin, Texas

IFMA Austin Second Vice President Olga White called to order a meeting of the IFMA Austin Board of Directors and Committee Chairs on Thursday, September 7, 2017 (11:43 am) at the Visa Building Conference Room in Austin, Texas. Board Members and Committee Chairs participating in all or a portion of the meeting were Kevin Blackburn, Todd Coleman, Joe Latteo, CFM, Derek Murakami, Olga White and Scott Slaughter. Also in attendance was Jim Coles, CAE, with the IFMA Austin Chapter.

Opening Remarks

Olga White thanked everyone for attending the Board Meeting. She received a call from Aimee Janousek at the beginning of the meeting and announced that Aimee Janousek had passed her CFM examination yesterday. The Board congratulated her over the phone.

Committee Reports

Golf

Jim Coles, CAE updated the Board on the Golf Tournament and presented a graph of the income and expenses. After netting out the Annual Sponsors, the golf tournament made a profit of \$10,520. This was the largest profit from a golf tournament in the last three years.

Communications and Social Media

It was reported that Sommer Holcombe has been active posting IFMA Austin Chapter events on Facebook.

Special Events

The Holiday Party with Capital Cruises has been set for December 7, 2017 from 4:00 – 7:00 PM. Now that the Golf Tournament is done, there will be early marketing for the Holiday Party. There was a discussion regarding the allocation of two complimentary registrations for every Annual Sponsor. The boat will hold 51 people and with the sponsor allocations of 26, there are only 25 places left. It was decided to go ahead and send the Memberclick invite and also ask every Annual Sponsors if they want to attend. The deadline was set for November 1 for a response from the Annual Sponsors. Scott Slaughter, Joe Latteo, CFM, Kevin Blackburn, Aimee, Olga, Jim Coles all announced they would attend.

He reported that five existing sponsors have renewed, one has dropped to a lower sponsor level and two have decided not to renew. Scott Slaughter brought up the issue of non-member associates paying associate member rates at the monthly luncheon. There was a detailed discussion on ways to charge non-members the correct registration amount. Jim Coles, CAE will research MemberClick to make sure that non-members are being upcharged when registering.

Executive Board Session

Approval of Board Minutes

Olga White presented the minutes from the September 7, 2017 Board Strategy Meeting. After a review, the minutes were approved as presented.

Jim Coles, CAE presented the financial report, which consisted of the August Profit and Loss Report, Balance Sheet as of July 31, 2017 and the Year To Date Profit and Loss Report (July-August). He noted that there was \$17,261 in the Wells Fargo Checking Account and \$12,313 in the Amplify Business Account. He also reported that there was a net income for the year of \$2,627. After a brief discussion, the financial report was accepted.

Other Business

There was a brief discussion regarding the donation from the proceeds of the golf tournament to relief efforts for Hurricane Harvey. It was decided to postpone the decision until Aimee Janousek would express her opinion. The Executive Board suggested a donation amount of \$1200.
